<p>Programme Update Handover was achieved on 27th October 2020. Commissioning is underway with the target to open the Outpatient Department on 19th November 2020 and the Theatres on 23rd November 2020.</p> <p>Community Benefits Community Benefit targets were presented to the Programme Board Meeting in February 2020.</p> <p>Statutory Approval Status Stage 1 Building Warrant has been approved by WDC. Stage 2 Building Warrant has been approved by WDC. Stage 3 Building Warrant has been approved by WDC. An occupation certificate has been issued by WDC.</p> <p>Key Risks and Mitigation A risk register review was undertaken at Senior User Group and some open risks have been transferred to the division risk register.</p> <p>Recruitment In line with the recovery plan there is a requirement to accelerate the recruitment to the Eye Centre posts over and above those posts recruited to as part of the workforce plan required in year one of opening. This means an increase from 3.4 theatres to 6 theatres by March 2021, as per the Organisations recovery plan. This expansion will be incremental as and when recruitment is successful.</p> <p>Commissioning Commissioning of the Eye Centre is well underway. The first Outpatient Clinic is planned for the 19th November 2020 and theatres will start on the 23rd November 2020. Some changes have been required to be made to both the patient pathway and the physical environment to support physical distancing for patients and staff. All 6 theatres and clinical</p>		

rooms have been equipped and will be ready to support NHS GJ Recovery Plan

Assurance Review

The final report has been issued by HFS on 6th October 2020. The Expansion Team in conjunction with the Advisor Team have developed an action plan to accompany this report and monitor actions through to completion.

<p>Works on site Kier commenced a “soft start” on site w/c 6th July 2020 which included electrical works and site clearance. This allowed major excavation to commence w/c 20th July 2020 and the piling to be undertaken thereafter. This is now complete and ground works and drainage are underway.</p> <p>Design The external design of the Surgical Centre has been updated to reflect elements of the Eye Centre. This relates to material selection and lighting features. The revised proposal was signed off by the Senior User Group on 2nd November 2020.</p> <p>Clinical Work stream group update Work stream meetings commenced in mid-September 2020 to plan the initial requirements for the refurbishment of CSPD, Pharmacy, Orthopaedic Outpatients, Theatres, and PACU. Stakeholders included GJ staff and expansion team, IBI, AECOM and Keir. A further 2 rounds of meetings are planned to sign off the rooms required and the proposed adjacencies, the next stage is a more detailed exercise to start the planning of the individual room layouts</p> <p>Work has commenced to provide additional preoperative recovery beds to support the utilisation of theatres 3 and 4. This work will create temporary spaces ahead of the larger refurbishment, completion is due by mid-November 2020.</p> <p>Key Risks and Mitigation A full review of the risk register will be undertaken during November 2020. A review of the PSCP risk register was held on 4th November 2020.</p> <p>Assurance Review The review is now in Week 9 and is currently scheduled to complete in December 2020. All technical workshops have been completed.</p>
