# 2 Report summary

# 2.1 Situation

All Boards are required to provide updates on delivery of their Annual Delivery Plan (ADP) by way of quarterly submission of Delivery Planning Templates to Scottish Government. Quarter 3 (October to December 2022) submissions were sent to Scottish Government on 27 January 2023, following approval and sign-off by the Executive Leadership Team.

The meeting cycle for the Finance and Performance Committee did not align to the timescales set by government for the Q3 return. As such the templates have been submitted in draft prior to Committee consideration of their content. This paper therefore seeks the Committee's approval of the Quarter 3 submission of the Delivery Planning

Templates. Should the Committee highlight any specific areas requiring changes these will be communicated to Scottish Government as necessary.

# 2.2 Background

The NHS Golden Jubilee Annual Delivery Plan (ADP) 2022/23 sets out the board's delivery priorities, with a suite of supporting templates providing more detail within a number of clinical and non-clinical areas. The ADP does not seek to provide full coverage across all board activities, and was developed in line with a specific commission from Scottish Government.

The Quarter 3 Delivery Planning Templates, included as appendices to this report, provide updates on progress against board deliverables as at the end of December 2022. This includes updated RAG status for each deliverable, and any changes to identified risks / controls, or delivery milestones.

Delivery Planning Templates were reviewed and updated by senior organisational leads working with the Quality, Performance, Planning and Programmes (QPPP) team.

The following templates formed the basis of the Quarter 3 return:

The Quarter 3 return was approved by the Executive Leadership Team on 23 January 2023. The Finance and Performance Committee is asked to consider and approve the update on 7 March 2023. This update will be presented to the Board on 30 March 2023.

#### 2.3 Assessment

A summary highlight report and the Quarter 3 Delivery Planning Templates are included as appendices to this paper. Progress updates at the end of Quarter 3 have been provided, as have updated RAG statuses for each deliverable. All updates within the templates are highlighted in bold text.

The following table provides an overview of delivery progress during Quarter 3:

The red RAG status relates to EP Cardiology. An ongoing challenge remains with long waiters, with projections indicating a risk that the service will not comply with 104 and 78 week targets. As at 31/12 there were 27 patients waiting over 52 weeks and a further 6 patients waiting over 78 weeks. Availability of anaesthetic resource is the limiting factor for long waits, however, growing demand for the service means that all procedure waiting

times are increasing. Activity levels in the West of Scotland still benchmark below the UK average.

Based on progress updates at the end of Quarter 3, changes were made to 7 RAG status indicators. Positively, 3 were upgraded from amber to green and 1 from red to amber, however, 2 shifted from green to amber and 1 from amber to red. Quarterly update reporting remains applicable for 1 closed deliverable as it was merged – *colorectal imaging to support surgery / bowel screening* deliverable is now merged with *establish colorectal imaging capacity*.

Table 2 provides a high level overview of these changes. Full detail is contained within the summary highlight report and corresponding Delivery Planning Templates.

Following the initial Quarter 3 submission to Scottish Government, an error was identified by the Divisional Management Team in the underlying data relating to the 12 week Treatment Time Guarantee (TTG) breach position within the Transcatheter Aortic Valve Implantation (TAVI) service. At this time, investigations are ongoing to understand the cause of the issue and agree the correct Q3 12 week TTG breach position. Operational leads within the Heart Lung and Diagnostics division and Business Services have taken immediate action to rectify the reporting error. Scottish Government is aware of this issue.
