# 2.1 Situation

Following our joint Strategic Partnership, Framework Agreement, and subsequent University status, NHS Golden Jubilee (NHSGJ) has been working collaboratively with the University of Strathclyde (UoS) on areas that we believe are deliverable and will have a direct, positive impact on healthcare services and our workforce.
